Alliance for Progress Charter School (LOWER SCHOOL) is accepting bids to prepare and paint the following previously painted surfaces to be completed the week of 7/8/19.

Materials Requested:

Semi-Gloss white paint (walls)

Rust-Oleum Royal Blue paint (Trim)

*Prep materials/Finishing caulk to be at the discretion of contractor

Touch Ups: 5 Classrooms (25 ft long x 26 ft wide)

Rm 109 - Side wall (behind bookshelf unit) patch all holes and repaint wall

Rm 113 - Back wall patch one hole and touch up paint.

Rm 112 - Back wall patch hole and touch up paint

Main Office - Patch hole and touch up paint

Rm 204 Patch small holes and touch up paint (wall next to door)

Rm 209 Patch small holes and touch up paint

Full Paint:

2 Hallways (1st floor hallway patch hole by exit door) (125 ft long x 8 ft wide x 7.5ft height)

1 Stairwell and patch work one hole (next to Cafeteria) (1 landing)

1 Stairwell (has 1 landing)

1 cafeteria (40.5 ft long x 25.5 ft wide x 7.5ft height)

\$100,000 Damage to Rented Premises Each Occurrence

\$5,000 Medical Payments

Commercial Automobile Liability

\$1,000,000 Combined Single Limit of Liability

Coverage to include Non-Owned Automobile

Workers Compensation Insurance

As required by the Laws of the Commonwealth of Pennsylvania:

Employers Liability - Each Accident \$100,000

Employers Liability - Each Employee \$100,000

Employers Liability - Policy Limit \$500,000

Professional Liability

\$1,000,000 Each Claim
