1 – Main Office Suite (25 ft long x 26 ft wide x 7.5ft height)

2 Stairwells (1 landing)

4 –Small offices (vary in size)

\$1,000,000 each occurrence

\$2,000,000 General Aggregate

\$2,000,000 Products and Completed Operations Aggregate (Fire)

\$100,000 Damage to Rented Premises Each Occurrence

\$5,000 Medical Payments

Commercial Automobile Liability

\$1,000,000 Combined Single Limit of Liability

Coverage to include Non-Owned Automobile

Workers Compensation Insurance

As required by the Laws of the Commonwealth of Pennsylvania:

Employers Liability - Each Accident \$100,000

Employers Liability - Each Employee \$100,000

Employers Liability - Policy Limit \$500,000

Professional Liability

\$1,000,000 Each Claim
